



CHILD RIGHTS PROTECTION POLICY

Siam Elegance Hotels&Spa accepts every individual as a child up to the age of eighteen, except for the case of being a minor at an earlier age according to the law that can be applied to a child.

Siam Elegance Hotels&Spa recognizes that every child has the basic right to life. Siam Elegance Hotels&Spa makes the maximum possible efforts for the survival and development of the child.

Siam Elegance Hotels & Spa recognizes the right of every child who has the ability to form opinions to freely express their opinions on all issues that concern them, by paying due attention to these opinions in accordance with the child's age and maturity level. For this purpose, the opportunity for the child to be heard either directly or through a representative or an appropriate authority in any judicial or administrative proceedings affecting the child is provided in particular to the child in accordance with the procedural rules of national law.

Siam Elegance Hotels &Spa respects the child's right to freedom of thought, conscience and religion. It respects the rights and duties of parents and legal guardians, if necessary, to guide the child in the exercise of his rights in a manner compatible with the development of the child's abilities. The freedom of a person to disclose his religion and beliefs may be restricted only for purposes such as protecting public safety, order, health or morals, or the fundamental rights and freedoms of others, provided that it is provided for and required by law.

Siam Elegance Hotels & Spa is aware that no child can be arbitrarily or unfairly interfered with in his family, housing and communication, nor can his honor and reputation be unfairly attacked, and that the child has the right to be protected by law against such interference and attacks.

Siam Elegance Hotels& Spa recognizes that every child has the right to an adequate standard of living that will ensure his physical, mental, spiritual, moral and social development.

CHILD RIGHTS PROTECTION POLICY

Siam Elegance Hotels & Spa accepts that every guest or child from outside our business who belongs to a minority based on different ancestry, religion and language cannot be deprived of the right to enjoy their own culture, believe and practice their own religion and use their own language together with other members of the minority community to which they belong.

Siam Elegance Hotels & Spa recognizes the right of the child to rest, to evaluate leisure time, to play and to have entertainment (activities) suitable for his age and to participate in cultural and artistic life. It recognizes and encourages the child's right to participate fully in cultural and artistic life with respect and encourages the provision of appropriate and equal opportunities for children to use leisure time, recreation, art and culture-related (activities).

Siam Elegance Hotels & Spa recognizes the right of the child to protection against economic exploitation and employment in any kind of dangerous work or in a nature that may be harmful to his health or physical, mental, spiritual, moral or social development.

Siam Elegance Hotels & Spa takes all appropriate measures, including legal, social and educational qualifications, to protect children from the illegal use of drugs and psychotropic substances as defined in international Decrees and to prevent the use of children in the field of illegal production and trafficking of such substances.

Siam Elegance Hotels & Spa provides protection of children against mental and physical threats. For this purpose, it takes all necessary measures at the national level and in bilateral and multilateral relations to prevent the child from being tricked or forced to engage in illegal sexual activity, the exploitation of children through prostitution or other illegal sexual activity, the exploitation of children through pornographic shows and materials.

Siam Elegance Hotels & Spa takes all necessary measures at the national level and in bilateral and multilateral relations to prevent children from being kidnapped, sold or subjected to prostitution, for whatever reason and in whatever form.

Siam Elegance Hotels & Spa makes the policy of protecting children and children's rights a part of the corporate culture by telling every staff member that when child abuse is encountered during initial orientation training and periodic trainings, the institution manager and the relevant Provincial security officers should be notified.
